### **Custodial History**

The Ronald Dworkin papers were transferred to Yale in three portions. The first and third portions was transferred from London to the Yale Law Library and from the Yale Law Library to Manuscripts and Archives. The second portion was transferred from Dworkin's offices at New York University to Manuscripts and Archives.

### **Conditions Governing Access**

The collection is open for research.

# **Processing Information**

Materials arrived to the repository in three accessions, two from London and one from New York City. The first two accessions were integrated during processing. A third, later accession was processed and arranged separately. All materials were refoldered and reboxed, and materials were rearranged to varying degrees.

More detailed notes on processing and arrangement are included in the description for each series or accession.

#### **Related Materials**

Books were removed from the collection and transferred to the Lillian Goldman Law Library for individual cataloging.

### Separated Materials

Duplicate material and some financial and real estate records were removed from the collection and returned to the donor. Some original clippings and copies of Dworkin publications were photocopied for preservation, and the originals were returned to the donor. Commercially produced cassettes and videotapes were removed and returned to the donor. Books were transferred to the Lillian Goldman Law Library at Yale.

Approximately 331.4 gigabytes of computer files were removed from the digital materials in the collection, including deleted, duplicate, system, and software files. The laptops and hard drive backups contained accounts and documents from other users in addition to Dworkin. Materials from these other user accounts were identified when possible and removed from the collection. 95 3.5 inch floppy disks, 5 5.25 inch floppy disks, 5 ZIP drives, 1 SuperDisk, 1 CD-R, and 1 laptop contained only separated files. These materials were stored in boxes 29, 30, 32, and 35 in the original accession of the collection. Since those materials have been separated, those box numbers are no longer used.

### Biographical / Historical

Ronald Dworkin was a legal philosopher, law professor, and writer. He wrote widely in both the academic and popular press and was a faculty member at Yale University, Oxford University, New York University, and University College London. Dworkin was born on December 11, 1931 in Providence, Rhode Island. He earned a BA from Harvard University in 1953; a BA from Oxford University, where he was a Rhodes Scholar, in 1955; and an LLB from Harvard Law School in 1957.

After graduating, Dworkin clerked with Judge Learned Hand on the United States Second Circuit Court of Appeals. He then practiced law with the Sullivan & Cromwell firm in New York City. In 1962, he accepted a position as professor of law at Yale Law School, where he was later appointed to the Wesley N. Hohfeld Chair of Jurisprudence. From 1966 to 1969 he served as master of Trumbull College at Yale. In 1969, Dworkin left Yale to take a position at Oxford University, replacing H. L. A. Hart as chair of jurisprudence. Beginning in 1975, he held concurrent faculty positions at New York University and Oxford. At NYU, he founded and ran, with Thomas Nagel, the annual Colloquium in Legal, Political, and Social Philosophy. In 1997, Dworkin retired from Oxford and accepted a position as Professor of Jurisprudence at University College London.

Dworkin wrote and published extensively in both academic legal journals and the popular press. He published several books, including Taking Rights Seriously, Law's Empire, Sovereign Virtue, and Justice for Hedgehogs. In addition, he wrote frequently for a general audience in publications including the Observer (UK), the New York Times, and most frequently in the New York Review of Books, where he was a regular contributor from the late 1960s through 2013.

Dworkin married Betsy Ross in 1958; they had two children, Jennifer and Anthony. Betsy died in 2000, and Dworkin later married Irene Brendel. Dworkin died on February 14, 2013.

### **Scope and Contents**

The Ronald Dworkin papers document Dworkin's life and career as a law professor, author, and legal philosopher. Materials primarily document his professional career and activities, including his work at Yale University, Oxford University, and New York University, as well as his academic and popular writing. A smaller amount of personal material is included, primarily from his youth.

The materials primarily contain writings and correspondence by Dworkin and other authors. Dworkin's writings include published and draft manuscript and electronic copies of books and articles, outlines, and notes. Writings by other authors include published copies, reprints, and photocopies of articles and books, and are often related to or discuss Dworkin's work. Correspondence includes typed letters in both physical and digital formats, as well as email. The collection also includes conference and event-related papers, course materials, personal financial and legal documents, research materials on specific subjects, and press clippings and reviews, along with a smaller amount of photographs, memorabilia, and ephemera. Many folders contain photocopies, clippings, or offprints of articles on a range of subjects. Groupings which focus on a specific theme have been noted. Many materials are annotated, primarily by Dworkin, but also by other unidentified authors. Dworkin's professional activities are also documented in digital and audiovisual material in a variety of formats.

Materials document Dworkin's activities from his youth through his final years. Coverage is inconsistent, however, and only a small amount of material exists for the period from the mid-1970s through the mid-1980s. The most well-documented time periods are the late 1960s and from the late 1980s until the 2010s.

# **Collection Contents**

### Series I: Numerical Files, 1948-2006

13.33 linear feet (26 boxes)

The series comprises writings, press clippings and newspaper and magazine copies, correspondence, financial and legal documents, and other materials related to Ronald Dworkin's career as a writer, scholar, and professor. Some personal legal and financial documents are also included. These files consist of individual items and folders, all numbered and filed in numerical order by Dworkin. Items are generally marked with a number on the cover, first page, or folder, but numbers are not continuous, as many numbers are skipped or missing from the sequence

The writings in the numerical files primarily consist of offprints, photocopies, clippings, or printouts of published or draft versions of articles by other authors, as well as some writings by Dworkin. The writings often include a note or cover letter from the author. Many writings have annotations, primarily by Dworkin himself, but also by other unidentified authors. The authorship of many annotations is unclear. Materials with substantial annotations have been noted. The bulk of the writings are academic writings from the legal and philosophical fields, but they also include writings from popular newspapers and magazines.

The draft writings by Dworkin are often in a rough outline format and include drafts for articles as well as conference, course, and seminar lectures. Sometimes the final published title of the draft writing is unclear, or the draft is incomplete. Drafts have been identified when possible.

In addition to individual numbered items, the series contains a large number of numbered subject folders. These folders generally contain information on a topic or from a specific event. These may contain documents from across a wide range of time, regardless of their place in the numerical filing scheme. Documents within each subject folder are not generally numbered individually.

The series also contains a limited amount of correspondence. The bulk of the correspondence in the series is found in various subject folders; in general, however, the extent of correspondence is limited, and is primarily incoming correspondence. Correspondence outside the subject folders consists almost entirely of cover letters to articles or other writings.

Additional numerical files can be found in Series Accession 2019-M-0059.

Most materials were filed in numerical order by Dworkin when received by Manuscripts and Archives and are arranged under the "Arranged by Dworkin" heading. Occasional misfilings in this group were corrected during processing.

A smaller amount of numbered materials arrived mixed with other, unnumbered material. This numbered material was rearranged in numerical order during processing and is listed under the "Unarranged" heading.

A partial inventory of the series, created by Dworkin, is located in Series I.

Materials are filed in numerical order, as numbered and filed by Dworkin. The materials are divided into two groupings: "Arranged by Dworkin," consisting of materials filed in numerical order when received by Manuscripts and Archives, and "Unarranged," consisting of numbered materials which arrived mixed with other material, which were grouped and arranged during processing. The order of the files is roughly chronological, and generally proceeds from circa 1977 through circa 2011. However, the order is very approximate, and many exceptions occur. In general, it appears that materials are filed roughly chronologically by the time during which Dworkin used the item or folder, rather than by their date of creation.

This series consists of computer files documenting Ronald Dworkin's life and professional career as a law professor, legal scholar, and author. Materials include writings by Dworkin and other authors; correspondence, including typed letters and emails; course and teaching materials; and audiovisual materials.

Writings sometimes duplicate published articles or materials available in physical form in other series. However, a significant amount of unique writings are included, along with draft materials in a variety of stages. Correspondence in this series is significantly more extensive than that found elsewhere in the papers, and generally does not duplicate other materials. It includes both typed letters in digital format and emails, and covers a wide range of personal and professional correspondence which primarily documents Dworkin's professional relationships and activities as a scholar, professor, and author.

Files were extracted from one laptop, two external hard drives, two CD-Rs, two VCDs, two digital tape drives, eighty-four 3.5" floppy disks, and one 5.25" floppy disk. Materials created by Dworkin are primarily in common word processing, audiovisual, and email archive file formats. Particularly common formats include Microsoft Office documents in .doc, .docx, .xls, and .xlsx formats; documents in PDF, Wordperfect, and XYWrite formats; and email archives and backups in .pst, .emlx, .olk14Message, and .olk14MsgSource formats.

Floppy disks were used in Dworkin's office at New York University and document his teaching and courses there, along with his writings for the *New York Review of Books* and other publications. The hard drives, tape drives, laptop, and CD-Rs contain writings by Dworkin and other authors, course materials, correspondence, and other personal and professional materials.

Digital materials span circa 1985 to 2013 and are especially extensive for roughly 2005-2013. Dates listed in this finding aid were generally determined by file creation or modification dates. However, dates in the metadata for some files reflect dates of backups or transfers by the creator or donor. In these cases, processing staff provided approximate dates for this finding aid based on a survey of the files.

Materials were primarily accessioned through the Yale University Digital Accessioning Support Service (DASS) in 2018. Two digital tape drives were imaged by an outside vendor. Manuscripts and Archives staff then reviewed and processed materials using Forensic Toolkit (FTK) software. Using FTK, several categories of files were identified and removed: deleted files, duplicate files, file slack, files in the Recycle Bin, Thumbs.db files, resource fork files, DS\_Store files, and Quicken QDATA files. Files were checked against the NSRL Reference Data Set to identify common software and operating system files, and these were also removed. Some disks and hard drive user accounts were created by users other than Ronald Dworkin. Materials from these other user accounts were identified when possible and removed from the collection. For all retained digital materials, the original disks have been retained as well.

Processing staff attempted to maintain file and folder metadata wherever possible. However, due to technical limitations, folder, directory, and file metadata was changed or added in some cases, and reflects the date of processing in 2021. Individual file metadata has been maintained and reflects the state of the files upon their transfer to Manuscripts and Archives. Original metadata for all directories, folders, and files has been retained in file manifests generated during processing.

Series IX is arranged into four groupings: external hard drives, laptop, optical media, and floppy disks. Items are arranged chronologically within each grouping.

### Accession 2019-M-0059: Additional Material, Circa 1960s-2011

This accession primarily contains Dworkin's professional correspondence. Correspondence includes discussions of writings and courses with colleagues, logistical correspondence related to Dworkin's attendance at lectures or conferences, and correspondence with publishers regarding Dworkin's writings. Correspondence with prominent individuals and organizations in academia and law are filed in individual folders, as are those of correspondents with whom Dworkin exchanged three or more letters, and those with individual folders of correspondence in Series III. Other correspondence is grouped in general folders by letter and arranged in alphabetical order. Additional files contain course and teaching materials from Dworkin's time at the University of Oxford; conference and event files, generally for events related to law or philosophy; and writings by Dworkin and other authors. Materials date primarily from the late 1960s and the 1980s.

Materials in this series were originally filed loosely with related materials, sometimes in roughly chronological groupings. Materials were sorted into groupings and arranged alphabetically during processing.

Accession 2019-m-0059 is arranged under five headings: Numerical files, Conference and event files, Correspondence, Course materials, and Writings. Materials are arranged alphabetically within each grouping.

#### Numerical files

The numerical files in the Dworkin papers consist of individual items and folders, all numbered and filed in numerical order by Dworkin. These comprise writings, press clippings and newspaper and magazine copies, correspondence, financial and legal documents, and other materials related to Ronald Dworkin's career as a writer, scholar, and professor. More information on these materials can be found in the scope and contents note for Series I: Numerical Files.
